IP they are wanting to know anything that happens even just a scratch on the finger. IP Tony is also pushing for when you get a road worthy done you have to get the appliance weighed.

- **a.** JC we got free first aid training for Brigades, so that's great. Brigades just ring their Area Office and ask for it. GP we have one of the most dangerous volunteer roles, pretty stupid that they didn't want to provide free first aid. JC that's a huge win for the RFBAQ.
- **b.** JC AFAC will be in Brisbane next year.

#### 4. GRANT APPLICATION

- **4.1.** IS Pine Rivers Group Solar Panels & Battery
- a. IS Pine Rivers have just built a replacement 91 and they could make great use of them on that giving them provision to charge batteries and run lights etc. JC We would just put it down for what it was worth and assign it to that brigade. All happy for it to go to Pine Rivers.
- **4.2.** GN22/639 Wattlecamp Rural Fire Brigade \$10,000 Driveway
- a. JC South Burnett area, wanting to put a driveway down. They get a levy of \$10,000 a year. They have \$29,000 in the bank and they are going to fund the rest. JC All up there is 11 million dollars available for station upgrades at what point do we refer brigades back to them when this is also what we do? IS if we refer that brigade back to the fire service, I don't think it would look good for us. JC no, that's why we raise money to give to brigades. GP how much money is in the bank? AR we have a lot. GP do we just give them \$5,000. AR we have the money to give them the full amount. DM I feel like the amount they are willing to put in and because we have the money why not give them the whole amount. NB I am happy to give it to them, but I do wonder are we giving to much away that the government should be giving to them. IS approve this one but refer any future to QFES. JC we could write to RFS and ask them about it so we can then let Brigades know. All SEM members approve.

**Motion:** RFBAQ to write to the Rural Fire Service in relation to the Station Improvement Funding that is available and ask what the requirements are and how Brigades can apply for it.

#### 5. GENERAL BUSINESS

5.1. JC – Cell Fi Go

- a. JC we have one here. 39 downstairs waiting to be posted, just waiting on addresses from TJ. A few brigades no longer want them but that is fine because it will go on to the next brigade in line. This was from a grant we applied for so it will only cost us staff wages & postage cost. Fire Service are organising the install. DM very well organised.
- **5.2.** JC Yellow Ribbon Day & Parliamentary Friends of Rural Fire Brigades
- a. JC This is all about the power of brigades, this is not about the RFBAQ. We have got people wanting to come from WA. Food & drinks is paid by a sponsor. Fire Service and Ministers Office are onboard. Swado wanted ties, so I have ordered ties. GP We need tie bars. JC gave overview of how it will run. JC 7 volunteer's that are coming who will be paid for by the fire service. JC gave background on the 7 volunteers who will be attending. Alan has a bus so people can go to Kedron and catch the bus to parliament house. Its looking to be very popular.
- 5.3. JC Innovation Platform Handover
- a. JC should be here in the next hour. Brigade is picking it up on the 3<sup>rd</sup> and taking it to Gold Coast Group games on the 6<sup>th</sup> and handover on the 7<sup>th</sup>. It's been at Quikcorp for a long time, and they have only just started work on it. We learnt a lot off it, the vehicle was free. IP there is no GWN in the G-Wagon. JC we can't manage it as we are not the Fire Service. GP is Bill going? JC we have sent him text, emails. Majority of the time I don't get anything back.
- 5.4. JC Bushfire Heavy Attacks
- a. JC TJ & Bolger have said no. We had a meeting last week and now MW has been tasked to borrow one from the CFA to take around to brigades and the RFBAQ will do feedback forms. We wanted two heavies to go around side by side but it didn't happen because of them. RFBAQ solution was to borrow one for 6 months so we can take it around and get feedback on them. The Commissioner agreed to that, and Mike Wassing has been tasked to do that. It will probably be driven around by Rural Fire paid staff. My suggestion is an RFBAQ rep go as well to make sure feedback forms are handed out & filled in. We could have next year the RFBAQ driving around in a CFA fire truck. GP should follow the cruiser around. JC yea if it arrives in time. GP who is Bolger's replacement going to be? IP we don't know that. JC we will probably find out next week as it will be announced at ELT.
- 5.5. JC Guardian
- a. JC We will be trying to get onto Senator Murray Watt to go field test them. The Minister's office is supportive & are trying to set up a meeting. We just need them to say yes. IP Guardian is the program the governments use. GP what happen to the tracking system on the cruisers? JC it didn't work. Its now apart of the Guardian system.
- **5.6.** JC Fire Danger Rating Signs
- a. JC Pikey has a meeting on Sunday about this. We asked the state executive for \$500,000 to go towards solar powered electronic Fire Danger Rating signs that have community messaging that is also a scheme that brigades & councils can buy into. The fire service have come back with no community messaging & no buy in scheme. The Fire Service has said we can do it, but



it will be completely separate to the one they do. They have also said they have received money from the Federal Government, so they don't need our money anymore. GP – I move we withdraw all offers of funding to that project as of now. IS – is there any way we could put up those signs ourselves? IP – you can do it yourself as long as its compliant with national standards, but they won't be run by the fire service. DM – if we did it who would update it? JC – if we did it, we would need to update them. JC – My suggestion is we have \$500,000 allocated for this project and Ash has offered another \$500,000. My Submission would be doing 200 x \$5,000 buy local Rural Fire Brigade grants. Would be a simple form and would need to be from a local supplier. Would be 3 rounds run across the financial year. We originally took this to the State Executive for the \$500,000 for the Fire Danger Rating Signs so I think we need to go back to the State Executive and let them know we can't do it because of these reasons and do you like this new grant scheme instead. This would be the largest scheme we have ever done. IS – is the Minister aware we are wanting to do something else? IP yes, he is. JC – they love the idea.

**Motion:** The RFBAQ Management Committee recommend that the State Executive discuss at the Annual General Meeting about withdrawing our offer of \$500,000 for Fire Danger Rating Signs as they will not be what was agreed upon with the Rural Fire Service. The Management Committee also recommends we run 200 x \$5,000 buy local grants instead.

#### 5.7. JC – Crew Sprays

- a. JC Cedar Creek Wolffdene has 2 lveco and 1 is at QuikCorp being measured up for CAFS unit which will be activated from the cab. Robert Lang had \$100,000 he is still chasing from the mining company that was fined for unsafe work practises, which will be used towards crew sprays.
- **5.8.** JC Western Equipment for Depopulated Areas
- JC That's the skid. There are now less people in central & western areas. There is a a. possibility of having more slip-ons than there are people. So, it was how do we keep volunteers on the fire ground longer without having to leave to fill back up with water. Landowners out there buy their own skids. Overlap that with there is talk of some very small councils being amalgamated so there will be less council staff. The idea is to have skids for fire season which would come off at the end and being serviced and stored at the council / rural fire depot. The idea would be to be able to move them around to where they are needed. Nutank in Rockhampton is already a supplier they know. The plan was to go out there in February with no uniforms and take a little truck with a 5000-litre skid on it and a 7000 litre trailer behind it and see some councils & landowners etc and see if they like the idea etc. Then after that, that's when it should have gone to the OSWG. We know there is less people in western QLD but we are not changing the equipment we are sending out there. If we brought the skid, we would put it on a truck, logo it up and take it around then give it away after that. IS – where are you getting the truck from? JC – the fire service would give us a flatbed truck. We have been speaking with the local rep, RFS, the Commissioner, the Queensland country & life about it as well and everyone really likes the idea. Iona RFB are getting a skid to have in their shed and when it is needed, they will put it on a truck to use it. IP - I think we should look at getting legs for these tanks. JC – how much does that cost? IP – not sure they are pretty simple. JC – My concern with that would be workplace health and safety. If we have it in a council depot they would be forking it on & off. I'll talk to Langy because he knows the guy from Nu-tank. We could bill the fire service for this, we could just go & pay for it and get them to reimburse us.



The 2000 litre trailer that is now available on Stores was our idea, the fire service tried to fight it, but it went through. This will be the same thing; they will fight it then do it. JC – send me an email with what you want on it, and I will get them to requote it. If you like that we can go ahead.

#### **5.9.** JC – Fusion Cruiser

a. JC – water comes out of it now. There were kinks in the line, and it had the wrong fittings on it, and it was letting air in. It would appear there was no testing done on it. It's bad build quality. They hadn't done half of the stuff they were supposed to. It will go back to QuikCorp Christmas to be fixed.

Meeting resumed 12.24pm

- 5.10. JC Summits
- a. JC 3 summits next year, you were deciding what you wanted to do with rep attendance. If they all go to one for the General Meeting. Who attends the others etc. IP it's a bit expensive for everyone to go to all of them. IS where are they? IP Cairns, Rockhampton & Twin Waters. Do we do the Rockhampton one as the General Meeting? JC The Rockhampton Summit is in June & we usually have our general meeting in March with every second year pushing it back to May to coincide with the Summit. We will still have a stand at all 3 and have the fusion cruiser there but we need to decide who attends what summit? IP The Cairns one, everyone would attend as it will be the General Meeting. Then split gladstone and up into the central area would go to the Rockhampton Summit, then the reps below gladstone and into the west would go to the Twin Waters Summit. JC so the reps from where the brigades are drawn from will go to that summit? IP Yes.

Resolution: Entire State Executive will attend the Summit that coincides with the General Meeting, which will be in Cairns in May. Then the other 2 summits will have the reps attending from within those areas. RFBAQ will have a stand at all 3 summits with the Fusion Cruiser going as well.

- 5.11. IS Privacy Issues with Dash Cameras as fitted to Fire Appliances
- a. IS Fire Service put dash cams in all the vehicles in my district, which records all the voice inside the cabin as well. There was no consultation about whether we wanted it or not. I think they overstepped the mark by putting them in and not consulting with the brigades first. IP must have only been in your area, there is none in our areas. JC are the brigades aware of the concern? IP id ask them if this went through the modification process. IS you can mute the microphone and if you get the application, you can delete the conversations and videos. JC there should have been an agreement from everyone first. They should take them out until they have that conversation with the brigades, they would never do this to a red truck. IS do we approach it from the top or district? JC they are saying it's for safety, but they are harvesting everyone's conversation. IS I am inclined to approach it with the Commissioner. IP we have a meeting coming up with the RFSQ, we could put it on the agenda for that. We could ask what consultation was done and what authorisation did Area Office have to change those trucks? IS yes.



**Resolution:** Raise the issue with the RFSQ Assistant Commissioner and ask what consultation with Brigade members was done, did it go through the modification process and what authorisation did Area Office have to instal them. Furthermore, that brigade members be advised that they are within their rights to turn it off.

#### 5.12. JC – Areas/Regions

- IP Commissioner let out about the review. We told him we want a western region. We a. worked out we could do with 5 regions instead of 7. JC - In our last Commissioner meeting he spoke about structure. The structure he suggested was the one we have now. We said no and that's not what we submitted to KMPG. They also asked what structure we see underneath that. We asked if we are tied to the current area/regional boundaries etc which they have said we are not and we can come up with any area/regions. So what we come us with is having less regions but more areas. IS - is this for after that restructure? IP - we are wanting this to occur when the restructure takes place. JC – it would be less regions but more area offices. JC - there would be another border country area office which is either Warwick or Stanthorpe & also another one at Cape York. GP – why are you considering a border country? IP – Ross Stacey said its his hardest area to work with. It would make it easier for brigades to go into their area office. JC – fire service put in a submission about that about 2 years ago and that where the other area offices are coming from. Which means more BTSO & ATSO & Inspectors for brigades. JC – There is an appetite for change, and it is coming soon. JC – what do you need from region that you can't get from area office? IS - they provide the money. GP - The state budget needs to be increased to accommodate that. IP – we would be dropping 2 regions and picking up 2 areas so we are probably better off. JC - take it away with you and have a think about it. GP - who instigated this conversation? IP - we did.
- 5.13. IP Olga Wilson Trust
- a. IP Olga Wilson trust finishes on 13<sup>th</sup> of August 2022.


#### **Operations Manager Report – July Management Committee Meeting**







